Sellers Representations

The following representations and conditions apply to the sale of the aforementioned dog:

a) As of the date of this agreement, the dog is in good health and free of communicable diseases. She/he has had a thorough vet exam before leaving and all vaccines are up to date.

b) The buyer has ten (10) days to have this dog examined by a veterinarian and to personally inspect the dog. Any claims must be made within this period and will be verified by Seller's own veterinarian. Congenital defects are guaranteed until one year old unless stated below.

Determination of what constitutes a heredity defect is to be by the unanimous agreement of two (2) veterinarians agreeable to both parties. One of these veterinarians must be a tenured faculty member of an accredited University veterinary teaching hospital or Board Certified in the applicable specialty. The cost of these opinions are to be assumed by the buyer.

Seller will replace with the next like available prospect or mutually agreeable animal provided the living dog and its registration papers are returned to seller. If replacement is warranted, shipping/transportation must be paid by the buyer.

Consideration

This dog identified in section 1 is being sold for the amount of \$_____.

This dog is being sold as a pet, on a spay/neuter basis only. Papers will be forthcoming once I have received documentation from your veterinarian proving that spay/neutering has been performed. This will be done within six (6) months of purchase.

Maintenance

a) Buyer agrees to maintain this dog in good health, provide routine preventative health care including, but not limited to, inoculation, internal and external parasites, and where indicated heartworm preventative medication.

b) Buyer agrees to feed this pup a proper diet of high quality dog food. Foods NOT to be fed include highly commercialized brands with artificial preservatives.

c) Buyer agrees that his dog is NOT to be LEFT IN A BACKYARD OR KENNEL ONLY. This dog is sold with the understanding that it is to go to selected parties and that the Buyer allow this dog to become part of the family. (This is to assure proper development and maintenance of the temperament)

d) Buyer agrees to provide seller with photographs and allow such photographs to be posted on Sellers website if so chosen.

e) Buyer agrees Seller will REPOSESS DOG UPON EVIDENCE OF NEGLECT AND/OR ABUSE at NO expense to the seller.

f) If at ANY time the Buyer should decide to give the dog up, Bella Papillons will have first right of refusal. Buyer understands that they will not receive a refund rather, after Bella Papillons has found a new home for the above mentioned dog, will receive their monies back less the cost of advertising and maintenance. The Buyer understands that older dogs are not easy to sell and it may be necessary to find a free adoptive home.

g) Buyer understands that Seller is available to answer questions regarding care, feeding and training of dog at Sellers home phone number anytime they are needed.

h) Buyer will not allow the veterinarian to use LEPTO in the inoculation of this dog.

Contract Amendment

Any Changes or additional terms to this agreement must be in the form of an addendum and signed by all parties.

Severability

If any provision of the Agreement is or becomes void or unenforceable for force or operation of law, the other provisions shall remain valid and enforceable. In the event of dispute, the Seller's home state, at the time of said dispute, will have jurisdiction over the matter.

Integration Clause

The entire Agreement between parties is contained herein and Buyer agrees that he/she FULLY understands this contract.
